SUBMISSION OF SUSPECTED FORGED GENERAL CERTIFICATE OF EDUCATION (GCE), ORDINARY LEVEL DEC.1979 BY ABENEMI SAM RANTI, THE DEPUTY GOVERNORSHIP CANDIDATE OF THE SOCIAL DEMOCRATIC PARTY IN THE SCHEDULED KOGI STATE GOVERNORSHIP ELECTION: APPEAL FOR INVESTIGATION AND PROSECUTION.

The above subject matter refers.

I am a member of the Social Democratic Party (SDP) and the Executive Vice Chairman for Central Senatorial Zone, Kogi State of Nigeria. I formally lay the following criminal complaint against Mr. Abenemi Sam Ranti, a purported member of the SDP and Deputy Governorship Candidate of the party in the Kogi State Governorship Election slated for 11th November 2023 as follows:

BACKGROUND FACTS

1. That in April 2023, the SDP conducted its primary election to nominate a Governorship candidate for the upcoming Kogi Governorship election slated for November April 2023.
2. The primary election produced one Jibril Sheik Ibrahim who in turn nominated one Ajodo Damian as his Deputy Governor.
3. That on the 20th day of May 2023, the SDP purportedly conducted a substitution primary election after the nominated Jibril Sheik Ibrahim, were said to have withdrawn.
4. It was said that Murtala Yakubu an APC Member emerged as the winner of the substitution primary and he later nominated one Abenemi Sam Ranti, the PDP State Chairman as his running mate and Deputy Governorship Candidate.



5. I instructed my Lawyers to apply to the Independent National Electoral Commission (INEC) for necessary documents in respect of the candidates who are not members of our party.
6. That upon obtaining the documents from INEC, I realised that the said Abenemi Ranti Sam attached to the Form EC9 (Substitute) a General Certificate Of Education (GCE), Ordinary Level Dec.1979 and stated in the said form that he obtained the result in 1979. Attached herewith and marked '**Annexure A**' is the Form EC9(SUBSTITUTE) and the supporting documents attached thereto including the said GCE Notification of Result Slip allegedly issued on 16/05/80.

CRIMINAL COMPLAINT

7. That upon reviewing Annexure A, particularly the attached WAEC GCE Notification of Result with number 14709101 issued on 16/05/80 to one 'Abenimi Ranti Samuel' in respect of a General Certificate of Education, Ordinary Level December 1979 Examination; I have reasonable grounds to believe that the said GCE Notification of Result/Certificate is forged or fake.
8. It is against this background that I write to respectfully implore your good self to urgently use your good office to order a full and conclusive investigation into the authenticity of this Certificate/Notification of Result and whether the said Abenemi Sam Ranti or Abenimi Ranti Samuel sat for such examination in the said year or whether his name is so reflected on the list of candidates for the year 1979.
9. I verily believe that where the Notification of Result is found to be fake and or forged, you will cause a prosecution of the said Abenemi Ranti Samuel and cause the report to be sent to the Independent National Electoral Commission (INEC) which has a duty to disqualify the said candidate from participating in the scheduled election.
10. Please accept the assurances of my utmost regards.

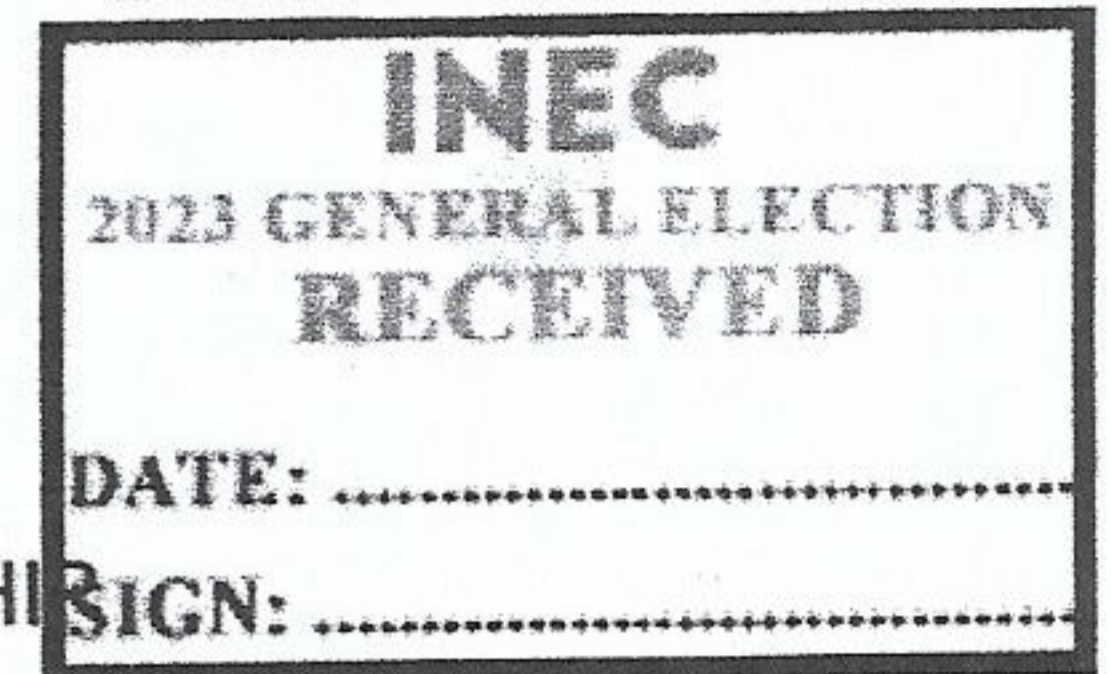
