COMPLAINT OF GIVING AND FABRICATION OF FALSE EVIDENCE BY ONE MURTALA YAKUBU IN SUBMISSIONS TO THE INDEPENDENT NATIONAL ELECTORAL COMMISSION (INEC) AND THE ALL PROGRESSIVES CONGRESS.

The above subject matter refers.

I am a member of the Social Democratic Party (SDP) and the Executive Vice Chairman for Central Senatorial Zone, Kogi State of Nigeria. I formally lay the following criminal complaint against Mr. Murtala Yakubu, a purported member of the SDP and Candidate of the party in the Kogi State Governorship Election slated for 11th November 2023 as follows:

BACKGROUND FACTS

1. That in April 2023, the SDP conducted its primary election to nominate a Governorship candidate for the upcoming Kogi Governorship election slated for November April 2023.
2. The primary election produced one Jibril Sheik Ibrahim who in turn nominated one Ajodo Damian as his Deputy Governor.
3. That on the 20th day of May 2023, the SDP purportedly conducted a substitution primary election after the nominated Jibril Sheik Ibrahim, were said to have withdrawn.
4. It was said that Murtala Yakubu emerged as the winner of the substitution primary.

5. That I have known the said Murtala Yakubu as a staunch member of the All Progressives Congress (APC), the Deputy National Publicity Secretary of the APC and a member of the National Working Committee of the APC who was cleared to contest the primary election of the APC but was restrained by a Court from participating in the primary election of the APC.
6. Shocked that Murtala Yakubu was now the Candidate of my party in a substitution primary election which was shrouded in secrecy and not known to party members in Kogi State, I instructed my Lawyers to apply to the APC to verify his membership status, his expression of interests and nomination forms and any other documents. The said expression of interest form is attached as '**Annexure A**' while the Nomination Form is attached as '**Annexure B**'.
7. That I further instructed my Lawyers to apply to the Independent National Electoral Commission (INEC) for Murtala Yakubu's Forms EC11B (Notice of Withdrawal of Candidate) '**Annexure C**' and Form EC9(SUBSTITUTE) '**Annexure D**' and the supporting documents attached thereto.

CRIMINAL COMPLAINT


8. That upon reviewing the documents, I realised the following:
 - a. The Nomination form has a declaration/affidavit sworn before a Notary Public where Murtala Yakubu declared that 'all the answers, facts, and particulars' he has given in his form are true and correct.
 - b. Mr. Yakubu's Form EC9(Annexure D) is also an Affidavit in Support of Personal Particulars which he specifically declared and made before the Commissioner for Oaths of the FCT High Court.
 - c. His date of birth is stated under oath in the APC Expression of Interest Form (Annexure A) and in the Nomination Form (Annexure B) as 13/02/1978 whereas upon the verification of his WAEC result which he attached to the Form EC9, (on WAEC's website at <https://verify.waeconline.org.ng/>), it shows that his date of Birth is 2/11/1978 as opposed to what was stated on oath. Attached herewith and marked 'Exhibit E' is copy of the result of the certificate verification.

- d. His name was stated in the APC Expression of Interest Form (Annexure A) and in the Nomination Form (Annexure B) under oath as '**Murtala Yakubu Ajaka**' whereas in his Form EC9 (submitted to INEC) also made under Oath, his name was stated as '**Murtala Yakubu**'. It is pertinent to note that Mr. Murtala failed to disclose/answer under oath in his Form EC9B to the question as to whether or not he bore a former name i.e., 'Ajaka' which he listed as his name under oath in 'Annexures 'A' and 'B'.
9. It is my belief that the contradictions outlined above in the personal particulars of Murtala Yakubu as stated on oath and submitted to the Independent National Electoral Commission constitute the offence of providing false evidence or fabricating false evidence contrary to **Sections 156, 158(2), 164 of the Penal Code**.
10. Specifically, it is my contention and complaint that the use of 13/02 (13th February) as his day and month of birth in Annexures B and C was false and amounts to giving false evidence or fabricating evidence contrary to Sections 156, 158(2), and 164 of the Penal Code as his day and month of birth are 2/11 (2nd November).
11. It is my belief that the failure of Murtala Yakubu to attach his WAEC Certificate to 'Annexure D' i.e., **Form EC9** is an attempt to prevent the detection of the offence.
12. It is my contention and complaint that Murtala Yakubu by stating under oath in 'Annexures 'A' and 'B' that his name was '**Murtala Yakubu Ajaka**' and stating in another Affidavit (EC9, Annexure D) that his name is 'Murtala Yakubu', amounts to provision of false evidence under oath. I further state that his failure to state 'Ajaka' as a former name in 'Annexure D' amounts to providing false evidence under oath as he indeed has a former name.

It is against this background that I write to respectfully implore your good self to urgently use your good office to order a full and conclusive investigation into this matter and prosecute Murtala Yakubu for the offence(s) stated above.
